### **LGA Adult Safeguarding Peer Challenge - update**

In 2016 East Riding of Yorkshire • Council requested that an Adult Safeguarding Peer Challenge of its services and the ERSAB be • undertaken.

The review, which took place in February 2017, used the LGA Adult Safeguarding Improvement Tool and a LGA associate to manage the process. The aim of the review was to seek an external view on ERYC and partners' ability to safeguard adults in the East Riding of Yorkshire; the review found:

East Riding of Yorkshire Council and partners can be justifiably proud of the strengths that have been identified with regard to leadership of the SAB working across organisations and developing and renewing the safeguarding strategy.

Findings of the team were listed as either strengths or areas for consideration.

### "East Riding are engaged and forward thinking"

Notable areas of **strength** were:

- ERYC demonstrate a high level of commitment to safeguarding.
- The SAT demonstrate strong team ethos and are enthusiastic, committed and supportive.

- SAB reporting, challenge and accountability are well established and well used.
- Strong evidence of family and carer involvement.

### "Prevention is what it is all about"

Suggested areas for consideration included:

- Improved community engagement with a consistent hearing of the voice of the service user.
- While the need for MSP is recognised it could be further embedded in all front line settings
- Feedback of outcomes need to be more consistently provided to the source of the concern.
- Learning from SARs could be disseminated more widely.

### "Safeguarding is always a learning journey"

Following the publication of the report, The Council is now using the findings of this peer challenge as a marker on its improvement journey and an action plan has been devised which will provide a framework for the monitoring and recording of this progress.

A presentation was provided by a representative from Humber Foundation Trust on the Mental Health Crisis Care Concordat to ensure the SAB is fully sighted on the issues concerned A presentation was also provided by the Care Quality Commission who gave an overview of the new structure and inspection framework.

The ERYC Housing, Transport and Public Protection representative provided an anonymised service user story detailing domestic abuse of an older person. A discussion followed on the on the use of the Vulnerable Adult Risk Management (VARM) protocol in these circumstances. Follow up actions from the recent peer and ERSAB performance reporting were other key items.



### **Training Issues**

Each newsletter we are going to focus on one particular type of abuse and this month we are looking at neglect and acts of omission.

#### **NEGLECT AND ACTS OF OMISSION**

### The safeguarding duties apply to an adult who:

has needs for care and support (whether or not the local authority is meeting any of those needs) and

is experiencing, or at risk of, abuse or neglect and

as a result of those care and support needs is unable to protect themselves from either the risk of, or the experience of abuse or neglect.

### Neglect and acts of omission can include:

Ignoring medical, emotional or physical care needs

Failure to provide access to appropriate health, care and support or educational services

Not washing, toileting or dressing someone

Failure to regularly change incontinence pads due to resources, leaving someone to lie in faeces/urine

Poor, neglectful care or practice and failure to provide appropriate skin care management can result in in pressure ulcers occurring

Withholding of the necessities of life, such as medication, adequate nutrition (not assisting someone to eat or drink) and heating.

### Symptoms can include:

Increased poor health and infection Weight loss Pressure sores Becoming angry Feelings of frustration Becoming resigned to situation Death



### Legislation

Wilful neglect is a failure to act rather than a deliberate act to commit harm.

On 13 April 2015 the Criminal Justice and Courts Act 2015 Sections 20-25 came into force. These sections create two new criminal offences of ill treatment or wilful neglect which apply both to individual care workers and care provider organisations. Previously, prosecutions for ill treatment or wilful neglect could only be undertaken where the victim lacked capacity or was receiving treatment for a mental disorder.

A new offence arises if a care worker ill-treats or wilfully neglects any other individual of whom he has the care by virtue of being paid to provide social care or health care for that person (whether a child or adult). It should be noted that any neglect should be "wilful" and that ill treatment requires a deliberate act or action that is reckless.

The offence carries a maximum penalty of imprisonment of up to five years and/or an unlimited fine.

### "WE ARE WATCHING YOU" DOG FOULING CAMPAIGN

### WE'RE WATCHING YOU... THE BACKGROUND

From the charity's 60 years of experience, Keep Britain Tidy knows what an emotive issue dog fouling is and how much it matters to people. As it is often cited as a key area of complaint and dissatisfaction from residents, we know how much it matters to you too.

That is why we looked for an innovative way to tackle dog fouling and help make positive changes to people's behaviour. Our research showed that some dog owners act irresponsibly when they think they aren't being watched. So as part of our Defra-funded "Social Innovation to Prevent Littering" programme we tested this idea and trialled a way to use it to reduce dog fouling.

### WE'RE WATCHING YOU ... THE EXPERIMENT

We worked with 17 land manager partners, across 120 dog-fouling hot-spot sites to trial this innovative glow-in-the-dark eyes signs. We monitored dog fouling incidents both at the target sites where the signs were displayed and at displacement sites up to 100m away. Overall the experiment showed a 46% reduction in dog fouling incidents.

We trialled variations of the sign, all with the same glowing eyes and "thoughtless dog owners we're watching you" message, but each with a slightly different angle. So whether your authority is currently focused on an enforcement message, or would like to use positive reinforcement or peer influence to make your point, we have different signs to suit your needs. Each sign type showed a greater than 40% reduction in dog fouling incidents.

### WE'RE WATCHING YOU ... THE CAMPAIGN

Now we have done the research, we want as many partners as possible to take part in our national campaign to reduce dog fouling around England. We launched the campaign with over twenty new partners in November 2014 and will continue to roll out the campaign in March 2015.



The press and public have shown great interest as we've launched the campaign, and coverage has included national press (e.g. the telegraph), national TV (e.g. Good Morning Britain and BBC 1), national radio (e.g. Five Live), a range of regional press and wide web/social media coverage.

#### Town and Parish Council Name Banks

The East Riding of Yorkshire Council has implemented a review with the aim of increasing the involvement of its Town and Parish Councils in the preparatory stages of the Street Naming and Numbering (SN&N) process and when implemented will encourage the use of names with a local or historic significance, or that reflect the ecology of the area.

When a new street name is required, the SN&N section presently liaises between the developer and the Town/Parish Council until a street name is agreed. Ideally, when a new street name is required, the SN&N section would forward to the developer a Town/Parish Council name bank from which to make a selection. In 2014 the SN&N section contacted all Town and Parish Councils requesting they supply new, updated name banks but which have largely not been updated.

We now request your Council submits a new/updated list of names it feels would be appropriate as street names. Developers will be required to choose names from this approved name bank. No other names will be considered unless in exceptional circumstances and at the discretion of the Address Management Team. The submission of the name bank will eliminate the current consultation period.

Your Council will be notified of those names chosen and given the opportunity to 'top up' the name bank for future developments.

If you do not, or are unable to submit a name bank, the Address Management Team will provide its own names and consider any suggested by the developer. Your Council will then be notified of the decision.

Name banks can be updated at any time and you will receive an email reminder every 6 months to review your current entries. All proposed names will be reviewed by the Address Management Team to ensure they meet the current Street Naming and Numbering Policy Naming Conventions.

When choosing a name (prefix) for a new street please consider the following:

- Preference is given to names which refer to local heritage and landscape features of the local area.
- To avoid confusion, new street names must not duplicate any similar name already in use in the local area.
- Names which relate to developers are not normally allowed.
- Names identifying living persons are not normally allowed.
- Surnames of persons (living or deceased) may be allowed if it can be shown they have or had a connection to the local area where the development is proposed. If the full name rather than the surname of a deceased person is suggested:
- O The person must have been deceased for twenty years or more\*, and
- o Written approval must be received from the next of kin or estate administrators. The Council will give reasonable consideration to applications where this may prove difficult, for example, through the passage of time.
- A variation in the street name suffix will not be accepted if the prefix of the street name is duplicated. For example a request for 'Church View' off an existing 'Church Road' will not be accepted.
- When a new road is an extension of an existing road it will not be given a new street name but properties will be numbered into the existing road unless the new properties do not fit into the existing numbering scheme.
- New streets can be considered for a development of two or more properties, depending on the layout, and following consultation with the Local Street Gazetteer team.
- Street Names will not include numeric characters or punctuation
- Street Names will not be difficult to spell or pronounce
- Any proposed name that the Address Management Team deems inappropriate, offensive and/or misleading will not be approved.
- \* English Heritage guidance on their awarding of commemorative blue plaques.

We encourage Town and Parish Councils to propose as many names as possible to create an extensive and diverse list. If we have previously received name

suggestions, these have been reviewed and are available to amend.

#### Safe & Sound Fund:

A pot of money is available to residents across the East Riding to help them minimise the fear of crime by increasing their home security.

The safe and sound scheme, run by East Riding of Yorkshire Council, allows people who may be vulnerable, to apply for additional home security measures such as additional locks for doors and windows, door chains and window alarms.

To qualify, applicants must be aged 60 or over or disabled and be a home owner, private sector tenant or housing association tenant and the combined savings of everyone living in the household must not exceed £5,000.

The scheme is not available to anyone who is council house tenant.

Successful applicants will be entitled to a free home security assessment and the fitting of any security measures.

To apply residents should request an application form by sending an email to safe.communities@eastriding.gcsx.gov.uk or by calling 01482 396380.

### How can you help me?

We can arrange for a qualified contractor to carry out a free home security assessment and fit home security equipment.

### What additional home security measures are available to me?

Measures include, but are not limited to\*:

- Additional locks for doors and windows
- Door Chains
- Door viewers
- Window alarms

#### How do I apply?

You can request an application form by sending email to an safe.communities@eastriding.gcsx.gov.uk or by calling 01482 396380.

#### What is a Safe & Sound Grant?

The grant is to help minimise the fear of crime by providing additional home security measures to enable residents to feel safer in their home.

#### Who is eligible for help?

To qualify for assistance applicants must be:

- Aged over 60 or disabled;
- A homeowner or private sector tenant / Housing Association tenant.

Everyone living in the property must not have a bank balance, when added together, of over *£*,5,000.

Further grants will not be made to anyone receiving support from the Safe and Sound grant scheme in the last two years.

### Community Payback: Requests now need to be made on-line:

In the Humberside area, over 160,000 hours of community, payback is completed every year by offenders on a community sentence. This equates to approximately £800,000 of free labour provided to local communities as offenders pay back for the crimes they have committed.

Community payback projects range from litter removal to clearing dense undergrowth, and environmental projects through repairing and redecorating community centres or removing graffiti. Offenders usually work as part of a team, monitored by a supervisor, and will work all day with short breaks, although there are some opportunities for individual placement.

The Humberside, Lincolnshire, and North Yorkshire Community Rehabilitation Company Ltd are working closely with the East Riding of Yorkshire Council to make sure that offenders do the things that you want them to do as payback for their offending. We are seeking your ideas for projects to be delivered throughout the East Riding in the future.

To be considered, your project must meet the following criteria:

- it must benefit the local community
- no one must make a profit from the work
- it must be challenging and demanding
- it must be worthwhile and constructive
- offenders must be seen to be putting something back into the community.

We also ask that you provide suitable rubbish bags and organise the collection of any cuttings and waste.




### **Breakdown by Parish and Town Council area**




### **Breakdown by Ward**





Are you going away at Christmas? Here is some advice on unoccupied properties:

- Consider using timer switches for lights. Ideally the lights should be set to come on and off at different times and be placed in different rooms.
- Consider asking fellow neighbours/family to check on your property on a regular basis.
- Ask someone to park a car on your driveway whilst you are away
- Consider installing external sensor lights if you don't have any, especially at the back and side of your home
- Consider locking garden gates to try and deter entry into your rear gardens if that's feasible.
