9 September 2019

PRESENT: Councillors Holmes (Chair), Armstrong, Bell, Gibbs, Sleight, Widd, Wright and Yeo.

Ward Councillors Beaumont and Greenwood.

Apologies were submitted from Councillor Stott.

Clerk: Alan Bravey.

The meeting was held at the Village Hall, Etton.

64/19 DECLARATIONS OF INTEREST - There were no declarations made.

65/19 MINUTES OF PREVIOUS MEETING – Resolved – that the resolution from minute 55/19 should be reworded to clarify Councillor Stott's and Gibbs roles in relation to the pond bid, and that the meeting minutes should then be approved as a correct record and signed by the Chairman.

66/19 WARD COUNCILLOR UPATE – Councillors Beaumont and Greenwood provided an update from East Riding of Yorkshire Council. They advised that they had spoken to Council officers regarding the hazard on the B1248, but the officers remained of the view that there were no further works that could be undertaken at the junction. It was recommended that the Parish Council gathered evidence on near misses and send it to the Police and Crime Commissioner and the Ward Councillors who sit on the Safer and Stronger Committee. The meeting also discussed using the community speed watch to tackle the problem of speeding lorries during harvest time. It was agreed to scope community interest in the scheme in the next newsletter.

67/19 CLERK UPDATE – The Clerk advised that Cllr Gibbs had submitted an outline funding proposal to the Heritage Lottery Fund and that an appointment had been made with a lottery advisor for feedback on the application on the 13th September. The Council's application for the "Year of Green" fund had been unsuccessful and a decision had not yet been received on the Sancton Wind Farm Fund application. Following consultation of Councillors by email, the Clerk had submitted comments of no objection to an application to fell a cherry tree, York House, Templar View and to a retrospective application to install an internal wall at Snilsworth Cottage, Main Street.

68/19 COUNCILLOR UPDATES – Councillor Holmes commented on the successful celebration event held at the Parkway Cinema to commemorate the 50th year of the Processed Pea. The Process Pea had been held in the Light Dragoon throughout that period and the Folk Club was as popular now as when it began in the Sixties. Councillor Holmes thanked founder Councillor Bell for his tremendous achievement and for the Processed Pea's contribution to life in Etton. On other issues, Parish Councillors raised a number of issues to be raised with East Riding of Yorkshire Council. It was noted that lampposts had been painted, but in matt rather than gloss, and that village benches had also been painted.

Resolved – i) that the Clerk would chase up the overgrown hedge on Cherry Burton Road, report the damaged manhole cover on Main Street near to Laburnum Farm, request replacement bollards for those damaged at the West End of the Village, request an update on the footpath works at the West End of the Village and request a road sweep of the village ii) that the Council note that Cllr Holmes had repaired the damaged bench on Warter Road.

69/19 CORRESPONDENCE – Councillor Holmes reported that following a meeting with East Riding of Yorkshire Council, a number of additional bus stop signs had been proposed and that ERYC had agreed to discuss these further with the bus operators. The Council noted that a resident had been advised of a change in bus stop locations, however, this was not connected to this piece of work, which only proposed additional signage.

70/19 VILLAGE TASK FORCE – The Council discussed the very positive work carried out by the Village Task Force under the stewardship of former Councillor Dicconson and expressed a desire to continue to support the initiative if another volunteer could be found to lead the work. It was also felt that residents could do more to keep the area outside of their own house tidy.

Resolved – i) that the Council would try and recruit a new Village Task Force co-ordinator and ii) an article in the newsletter would ask residents to help keep the village tidy.

71/19 TO CONSIDER PLANNING APPLICATION VARIATION OF CONDITIONS 2 (LANDSCAPING), 11 (MATERIALS) AND 17 (APPROVED PLANS) OF PLANNING PERMISSION 17/03660/VAR (VARIATION OF APPROVED PLANS FOR CONVERSION OF FARM BUILDINGS TO TWO DWELLINGS) TO ALLOW FOR ALTERATIONS TO DESIGN AND TO DISCHARGE CONDITIONS 2 AND 11 (PART RETROSPECTIVE APPLICATION) | HIGH FARM 113 MAIN STREET ETTON EAST RIDING OF YORKSHIRE HU17 7PG

Resolved –that the Parish Council had no objections to this application.

72/19 CAR PARKING, B1248 ETTON JUNCTION – Councillor Wright reported that she had observed cars parking on the B1248 slip road into Etton on a number of occasions recently.

Resolved – that the Clerk would report parking in the B1248 Etton slip road to East Riding of Yorkshire Council and request they consider additional road markings.

73/19 TRAFFIC ISSUES ON CHERRY BURTON BRIDGE – Councillor Armstrong reported that she had observed cars travelling over the Cherry Burton Bridge too fast and in the centre of the road, presenting a risk to oncoming cars, cyclists, horse riders and pedestrians. It was noted that there were already a considerable number of warning signs on the approach to the bridge and it was felt that these were more distracting than helpful.

Resolved – that East Riding of Yorkshire Council should be requested to review the number of road warning signs on the approach to Cherry Burton Bridge.

74/19 EVENTS AT THE VILLAGE HALL – Councillor Holmes commented that the number of events held at the village hall that brought all the village together had decreased over recent years. Councillors Gibbs and Wright sit on the Village Hall Committee and said that this correlated with a reducing number of volunteers willing to take part in the committee and

arrange events, and a general apathy of residents in attending events. It was noted that the primary purpose of the Village Hall Committee was to generate income to maintain and operate the hall so that it was available for members of the community to book and use. This was primarily achieved by the regular coffee mornings, where very few Etton residents actually attended.

75/19 ITEMS FOR THE VILLAGE NEWSLETTER – Resolved – That in addition to the usual items, the reporting of near misses on the B1248, the parish emergency plan, a request for volunteers to lead the village task force and a safety notice for the Cherry Burton Bridge should be included in the next newsletter.

2. Crime issues of particular note

3. Community Priorities

Op Galileo

Officers from across the East Riding of Yorkshire are now preparing for the start of wildlife offences and poaching across the ward area. Now that harvesting is coming to an end and land work well under way we see an increase in poaching offences. Officers will be using intelligence, new equipment and volunteers in helping to identify offenders and obtaining evidence to form prosecution cases.

Burglary

Operation Gallant continues to run across the region. Neighbourhood watch is a deterrent and brings communities together, for information relating to the scheme please visit your local station. The team are always keen to allay the fear of crime and will continue to analyse trends and intelligence to ensure the community remains safe. Please remember that it is the fear and the very notion of invasion that affects us with regard to burglary. Don't leave your windows open, look after each other protect your neighbours in particular the elderly and vulnerable. If you see anything report it no matter how trivial you may think it is at the time, it may well be that your piece of information has significant impact.

4. **Crime Reduction Advice**

Anti-social behaviour covers a wide range of unacceptable activity that causes harm to an individual, to their community or to their environment. This could be an action by someone else that leaves you feeling alarmed, harassed or distressed. It also includes fear of crime or concern for public safety, public disorder or public nuisance.

Examples of anti-social behaviour include:

Nuisance, rowdy or inconsiderate neighbours Vandalism, graffiti and fly-posting Street drinking Environmental damage including littering, dumping of rubbish and abandonment of cars Prostitution related activity Begging and vagrancy Fireworks misuse Inconsiderate or inappropriate use of vehicles

The police, local authorities and other community safety partner agencies, such as Fire & Rescue and social housing landlords, all have a responsibility to deal with anti-social behaviour and to help people who are suffering from it.

If you are experiencing problems with anti-social behaviour, or have any concerns about it, or other community safety issues, you should contact your local council or call the non-emergency number, 101. In an emergency, call 999.

We hope to include items of interest to update, inform and describe some of the issues and challenges facing us all in delivering quality services our residents demand and expect.

What are the Council's priorities?

With the increasing pressure on budgets, it is more important than ever that we focus on things that matter most in the East Riding. We have five corporate priorities to ensure we gain the most use of our limited resources.

These are;

GROWING THE ECONOMY — working with others to support sustainable economic growth and strong communities, ensuring the East Riding is a great place to invest in, live, work and visit.

VALUING THE ENVIRONMENT – Responding to climate change, developing our infrastructure and safeguarding our heritage.

PROMOTING HEALTHY LIFESTYLES – Helping people to stay healthy, strong and fit for the future.

PROTECTING THE VULNERABLE – Supporting in times of need, protecting from harm and improving the quality of life.

HELPING CHILDREN AND YOUNG PEOPLE ACHIEVE – Supporting and inspiring children to raise their aspirations and reach their potential.

TOURISM



The East Yorkshire coastline, the Yorkshire Wolds and the beautiful open countryside & Market Towns continue to be big attractions & growing numbers of visitors come to our area each year to enjoy the East Riding of Yorkshire.

Tourism was valued at bringing in £565 million to this area in 2017 & we expect that number to grow when the figures are updated later this year. The quality of accommodation & variety of attractions on offer have grown in recent years and East Riding of Yorkshire Council plays its part by offering a dedicated tourism team to offer support to businesses & provide a variety of events & activities for visitors throughout the area.

These are examples of 3 events provided over the summer

The "Wildlife Photographer of the Year" exhibition in the Beverley Art Gallery, with over 100 magnificent wildlife photographs together with sculptures by award winning artist Emma Stothard. The exhibition was free of charge and offered until mid-September.

Along the seafront from Bridlington to Withernsea, "Active Coast" provided a range of sports, arts, environmental and family-fun activities right through until the end of August. Again, all events were free of charge.

In addition, ERYC supported "Yorkshire Wolds – Walking and Outdoors Festival" from September 7th to 15th. Numerous walks and related events organised by ERYC and local groups took place in many different locations (some free, some with a small charge).

TACKLING YOUTH OFFENDING

The East Riding Youth Offending Service (YOS) has recently been judged by inspectors to be outstanding and was awarded the maximum marks. The YOS works with young people aged 10-17yrs that have been found guilty of a criminal offence, part of their work can include Reparation (commonly known as community payback or unpaid work). Within the youth arena the YOS works with young people doing reparation on a one to one basis with trained workers and generally work between 1-4hrs at any one time with a young person dependent upon their needs. The work must be giving back to the community, so cannot be for a business or any financial gains, also where possible the aim is to empower the young people with skill sets such as painting, planting/gardening, woodwork skills, baking skills (for events), assistance at events - setting up, putting down, being a runner on the day. The YOS is very much open to ideas as to work opportunities.

With the East Riding of Yorkshire being so vast it is important that there are opportunities across the East Riding, albeit this does mean that the work may not be completed imminently, but where best the YOS tries to accommodate.

CHILDREN'S HEALTH

The prevalence of obesity or children that are overweight in the East Riding of Yorkshire in 2017/18 has been measured at its lowest rate since the National Child Measurement Programme was introduced in 2006/7.

With statistics in the East Riding being lower than the national average and placing us 2nd in the country for Reception children and 21st for Year 6 pupils.

It is important to note that the proportion of East Riding children being measured is one of the highest levels of coverage in the country. As of the 19 July 2019, 98.9% of the current years Reception age children and 97.8% of Year 6 children had been weighed and measured equating to 6715 in number and across 124 primary schools. This comprehensive data helps us understand the overall effectiveness of our attempts to reduce children's overweight, obesity and excess weight prevalence and further improve the long-term trends.

The evidence shows that overweight and obese children are likely to stay overweight or obese into adulthood and are at higher risk of developing non-communicable diseases like diabetes, cardiovascular diseases and some cancers as well as their related diseases that are largely preventable at a younger age. Prevention of childhood obesity therefore is a high priority in East Riding of Yorkshire.

So, this remains a clear priority for us and something that we all will continue to work at with parents and carers and with schools through the Healthy Schools Awards programme and effective use of the Sports Premium.

Sometime ago discussions took place about how the council could

help the thousands of micro business who operate in the East Riding with advice and guidance on looking after the health & wellbeing of employees.

It was decided the best way to make information accessible was to produce an easy to use website that would provide guidance & advice on a wide range of topics.

We then decided this would be useful to all residents not just businesses and as a result the happyandwell.me website has been developed and launched.

The Councils Public Health team have spent the last 2 years working with local health partners on the production of the new website which can help everyone connect to ways to improve their health and wellbeing or get information on a variety of health-related issues.

From information about various conditions from cancer to dementia, for information on hobbies and exercise through to transport, the web site is a wealth of information to allow everyone to find ways of improving their health and wellbeing.

CAPITAL INFRASTRUCTURE INVESTMENT



Work on a major scheme to transform a congested section of the A164 between Beverley and the Humber Bridge is reaching its next stage.

The construction of two new roundabouts to relieve congestion and improve road safety at the junction of the A164, Great Gutter Lane and Riplingham Road began in March.

The existing staggered crossroad junction where Great Gutter Lane West and Riplingham Road East meet the A164 causes long queues and congestion particularly at peak times. To address these issues the council is progressing a scheme to replace the two priority junctions with two roundabouts.

The scheme is being funded following a successful £3 million bid to the Department for Transport for Transport's National productivity Investment Fund with the remaining funding for the £4.26 million scheme provided by the council.

The work is scheduled to be completed by Christmas of this year and will include;

- Construction of a new four-arm roundabout on the A164 at its junction with Riplingham Road
 East
- Construction of a new three-arm roundabout on the junction of Great Gutter Lane, Swanland Dale and Riplingham Road.
- Construction of a new link road between the two roundabouts
- The closure of Great Gutter Lane West between Swanland Dale and the A164 junction
- New fencing, lighting and landscaping

Work already completed includes the extensive diversion of water mains. Work by KCOM to divert their cable network in the area is continuing.

CLIMATE CHANGE



LOVE YOUR HIGH STREET



In this year's Council budget it was agreed that £1.4 million be made available to help communities revive town centres, through a project called 'Love your High Street'. The funding is to be offered to 13 principal East Riding Towns over the next three years. It will be paid as a 50% match funded grant of up to £5000.

There is also a minimum grant of £500 from smaller schemes.

The main criteria for Love Your High Street, learning from previous schemes, is to get equal 'buy-in' from the business community for projects aiming to;

- Help reduce empty high street property
- Bring greater footfall on a sustainable basis to the High Street
- Encourage community involvement and participation

No two towns are alike and we know from experience that given the opportunity local businesses and organisations have some great ideas about what change needs to happen to create thriving High Streets. We are confident our funds will help them achieve some successful solutions.

Members' Allowance Survey

INTRODUCTION

East Riding of Yorkshire Council's Independent Remuneration Panel called the Members' Allowances Panel, consists of four independent members who reside in the East Riding. One of the roles of the panel is to make recommendations about the allowances which can be paid to town and parish councillors.

The Panel is currently reviewing the allowances for town and parish councils and would welcome your views as to whether allowances should be paid and if so, what would be a reasonable amount. This questionnaire should only take a few minutes to complete.

In accordance with The Local Authorities (Members' Allowances) (England) Regulations 2003, town and parish councils may choose to pay their members an allowance from that town or parish council's budget, to recognise the time and effort they put into their parish duties. There is however no obligation on town and parish councils to pay such allowances. Each town or parish council may make an allowance available to its chair only, or to each of its members. Where all members receive an allowance, the amount payable to the chair may be different to that paid to other members, but otherwise the amount shall be the same for each member.

The Panel will use the information provided to produce a report setting out its recommendation as to whom a basic allowance should be paid and the level of the allowance. Ultimately however, it is for each town and parish council to decide if they wish to pay a basic allowance but in doing so they must have regard to the recommendations of the Members' Allowances Panel.

If a town and parish council chooses not to pay a basic allowance, they may alternatively pay their Chairman an allowance, which they think is reasonable for the purpose of enabling them to meet the expenses of their office, under with Section 15 of the Local Government Act 1972.

The Panel would like to thank you in anticipation for taking the time to complete this questionnaire and would be very grateful if responses could be returned by 24 November 2019.
