93/13 DECLARATIONS OF INTEREST – There were no declarations.

94/13 MINUTES - *Resolved* – That the minutes of the meeting held on 9th July 2013 having been circulated be approved as a correct record and signed by the Chairman.

98/13 Applications - *Resolved* – That the following comments be forwarded to East Riding Council on the application stated:

<p>(1) <u>Eric Bradley Construction Ltd, 89 Main Street – Erection of 4 Detached Dwellings (Ref 13/01894).</u></p> <p>Prior to considering this application Councillors visited the site. The Council was informed of views that had been submitted by residents to East Riding Council and which were published on its website, and also the views of the Conservation Officer. Details of the application had been circulated previously to Members of the Council.</p> <p>Following a discussion it was agreed in accordance with Standing Orders that the voting on this item shall be by secret ballot (For 3, Against 4)</p>	<p>(a) That the Parish Council object to this application and recommends that it is refused on the following grounds:</p> <ol style="list-style-type: none">1. The proposals are an over-development of the site.2. The proposed development extends outside the village development limits.3. The proposed development will change the linear nature of the village which is a conservation area. One of the few remaining Yorkshire linear villages could be lost if this development is approved. <p>(b) that the Parish Council also comment that in 2006 an application in respect of proposed alterations of outbuildings to form a dwelling adjacent to 28 Main Street which might have provided an affordable housing opportunity was refused by East Riding Council on the grounds that Etton was not a sustainable village and a subsequent appeal was dismissed.</p>

(c) the Parish Council feel strongly about this application and request that if Officers recommend differently the application is referred for determination by the Planning Sub-Committee.

104/13 ROUTINE MATTERS – The following matters were discussed briefly:

- Pothole near Junction of Etton Road and the B1248 Road – Further to Minute 52/13 it was reported that whilst East Riding Council had filled the pothole with road planings they had not filled in all the potholes. It was suggested that the whole section of the verge should be laid with tarmac. Agreed - That the matter be referred to East Riding Council.
