## ETTON PARISH COUNCIL

10 November 2015

**PRESENT:** Councillors Holmes (Chair), Bell, Armstrong, Boyd, Eggleston, Sleight, Widd and Yeo.

The meeting was held at the Village Hall, Etton.

**82/15 COMMUNITY LED PLANNING** – Peter Hirschfield from the Humber and Wolds Rural Community Council (HWRCC) gave a presentation on the benefits of holding a community review consultation event and developing a community led plan. The process could strengthen the relationship between the Parish Council and the community as well as providing a road map for future Parish Council activities. HWRCC offered to conduct the consultation on behalf of the Council at a cost, which could probably be met through a National Lottery Grant. The Parish Council discussed the difficulties in successful engaging with residents of the Parish and potential ways of overcoming the problem.

**Resolved** – (a) that the Clerk would submit a grant request to the National Lottery to fund this project.

**83/15 DECLARATIONS OF INTEREST** – There were no declarations made.

**84/15 MINUTES OF PREVIOUS MEETING – Resolved** – That minute 71/15 should be amended to show that Councillor Boyd had agreed to approach St Mary's Church and not Councillor Eggleston and that the minutes of the meeting held on the 8 September should then be approved as a correct record and signed by the Chairman.

**85/15 UPDATE ON MATTERS ARISING FROM THE PREVIOUS MEETING** – The Clerk reported that East Riding of Yorkshire Council had agreed to carry out a traffic speed survey in January. The new lamp post had been repainted but East Riding of Yorkshire Council had not yet commented on the request to revert to the original gloss green. Councillor Boyd reported that St Mary's Church had indicated that they may be willing to contribute to the replacement gate and gate post. Councillor Holmes reported that he had received an updated quote for additional work at the Church. The cost of the work was noted and Parish Council discussed whether the gate and post could be removed instead of reinstating.

**Resolved** - (a) that Parish Councillors would inspect the gates and posts at Church Walk prior to the next meeting so that a decision on replacement could be taken.

## Review of winter services policy

Information about this 3-yearly review, due to be reported in July 2016, has recently been sent to clerks of town and parish councils to ask for comments. East Riding of Yorkshire Council allocates the highways it treats into one of three network types : precautionary, secondary and most heavily-used footways.

The network is defined using approved criteria and no major changes are anticipated, so the winter services team is not looking to make additions. They are asking for comments about the service in general, potential service improvements and views on how third parties can help if the weather becomes particularly bad.

## Christmas bin collections

Collection dates across the East Riding for green, blue and brown bins will change over the Christmas period between Friday, 25 December and Sunday, 17 January. Collection dates will return to normal on Monday, 18 January.

Revised collection dates are available at [bins.eastriding.gov.uk](http://bins.eastriding.gov.uk). New bin collection calendars will be posted soon, showing the revised dates and all dates up to Saturday, 24 December 2016. You can also sign up to the council's free text reminder service – information is on the calendar and on the website.

Household waste and recycling sites will be open from 10am to 5pm, but will close at 4pm on Christmas Eve and New Year's Eve. They will be closed on Christmas Day, Boxing Day and New Year's Day.

Real Christmas trees can be recycled in the brown bin - remove all lights and decorations. Food waste including cooked and uncooked food, carcasses, bones, fruit and vegetable peelings should also go into kitchen caddies and the brown bin. Cards, wrapping paper and cardboard boxes can be put in the blue bin.

## Neighbourhood planning

## Christmas bake-off winners

Tasty festive dishes were cooked up by the finalists in this year's Christmas bake-off competition. East Riding residents came up with mouth-watering original recipes using Christmas leftovers to highlight how easy it is to save money by creating great meals from food some people might throw in the bin.

The six finalists made everything from a seasonal pizza to fruit cakes and flapjacks, and cooked their recipes at the Yorkshire Wolds Cookery School at Southburn, near Driffield. The dishes were tasted and judged by Michelin-starred chef James Mackenzie of the Pipe and Glass Inn at South Dalton, who was impressed by the standard. - age group 17 and over: Robert Bell with his recipe of Crispy Christmas balls, which used cold mashed potato, cold cheese sauce, and crumbs from stale bread mixed with smoked haddock.

## Christmas fire safety

Humberside Fire and Rescue Service is urging residents to put fire safety at the top of their Christmas lists this year. While fire safety is important throughout the year, the extra distractions of the Christmas season make it especially important to be vigilant so that families and loved ones are protected from fire.

Seasonal tips include:

- don't overload sockets, and ensure only one plug per socket
- switch off fairy lights and unplug them before going to bed, or going out
- check your Christmas tree lights are in good working order before use, and conform to the British Standard (BS EN 60598)
- use residual current devices (RCDs) on outdoor electrical equipment
- turn off plugs when they are not in use, except those designed to be left on like freezers
- do something good this Christmas by testing the smoke alarms of someone you know who may need help such as an older relative or neighbour.

Thanks Alan and Parish Council for this It is heartening to feel that the Parish Council picked up these points even though we were unaware at the time that any application had been put in.

### **Flooding in the Village**

An issue I didn't include in my objection and one that does not only apply to this extension but is the issue of flooding in the village

Ellerington Lane alongside Bank House Farm becomes a strongly flowing stream in heavy rain taking off water from the fields behind. There is a drain at the end of it into the mains drainage system which does not take all the water. Opposite my drive, 92 Main Street, is a manhole cover and water comes up through this in heavy rain. Although, there has been some amelioration since drains were improved, I think there still needs to be vigilance about the risk to properties further down Main Street. With this extension at 94, which has significantly larger rapid run-off roof area, additional bathrooms/wet room: the conversion of outbuildings at High Farm for 3? dwellings and the planned barn conversion and proposal in for another house at Beech Lodge there is potentially a significant increase on water moving through drains and increased flooding risk I understand that drainage from the new development in Bradley's yard was supposed to improve upon Bradley's drainage. I am not sure how given the size of the houses and the extensive area of fast run-off roofs it could be that they are already adding to water through the drains. However that was at least a brown field site with probably significant water use and run-off from shed roofs.

Fortunately, the grass field opposite us, in heavy rain holds an enormous amount of water. Rivulets gradually sink into grass as they run down the slope and small hollows fill to form small pools and puddles. Such water seeps gradually over hours or days into the soil and sub-soil It is fortunate that there is this natural water catchment area. Seeing this area throughout rainfall and Ellerington Lane after heavy rain has made me conscious of how vulnerable Etton is, because of its position in a valley, to potential flooding from rapid run-off and how important the maintenance of any natural catchment on the surrounding slopes is and the evaluation of developments in light of potential additional risk. Here at the west end on higher land we are not flooded but for people without knowledge of the village geography it would be easy to overlook the impact this area has on the 'downstream' Main Street properties.

I am happy for my email to be shared with Parish Council.

Our Community Patrol Officers will respond to incidents across the force area, equipped with mobile devices so they spend less time returning to police buildings.

This is good news for our communities as it will enable us to have flexibility where we need it to respond to emergencies, yet still be able to provide a local service in our neighbourhood's. It will also help us to work better with our partners to identify effective solutions to problems.

Public safety remains our absolute priority and these changes will ensure that we are able to consistently and effectively identify and resolve local problems, reduce crime and anti-social behavior, and improve the safety of our communities.

In order to ensure we have the right number of people in the right places when we need them most, we have discussed with officers and staff a new shift pattern. In an attempt to take account of individual preferences some people have moved locations so you may well see some new faces in your area. I am sure they will get to know you quickly and you should have the confidence to contact us and know we will respond to your needs.
