PRESENT: Councillors Holmes (Chair), Armstrong, Bell, Gibbs, Sleight, Stott, Yeo, Ward (from item 54) and Widd.

Ward Councillor Beaumont and Greenwood attended for items 52 - 54

Clerk: Alan Bravey.

The meeting was held virtually using Zoom.

52/20 DECLARATIONS OF INTEREST – There were no declarations made.

53/20 PARISH COUNCILLOR CO-OPTION – Resolved – That Charlotte Ward would be co-opted to the Parish Council.

54/20 WARD COUNCILLOR UPDATE – Ward Councillors discussed road safety on the B1248, and agreed to review the matter in January and consider whether to write a joint letter to East Riding of Yorkshire Council. Ward Councillors agreed to raise the Parish Council's request for urgent street cleaning on Warter Road, along with a request to consider installing an additional gully near to the Dalton Road junction. It was noted that speeding traffic was making Warter Road and surrounding roads very hazardous. It was also noted that the verges were in a very poor condition, and that there was a deep hole outside the rear entrance to Laburnum Farm, on Warter Road, which had been used as a passing place. Councillors Bell and Yeo offered to meet ERYC officers if required. Councillor Greenwood advised that she had written to ERYC regarding the street naming policy.

Resolved – That Clerk would write to Ward Councillors with details of the road cleaning required on Warter Road, the request for the additional gully and details of speeding traffic.

55/20 MINUTES OF PREVIOUS MEETING – Resolved – that the minutes of the Parish Council meeting held on the 14th September 2020 should be amended to correct the name of Appleton Fold, and then should be approved as a correct record and signed at a later date by the Chairman.

56/20 CLERK UPDATE – There were no updates.

57/20 COUNCILLOR UPDATE – Parish Councillors had been contacted by residents who had not had their bins emptied due to the road works on Main Street. The Clerk advised that ERYC had been unable to gain access with a refuse wagon and so had made arrangements to collect at a later date with a smaller vehicle. Residents were asked to present the bins as usual, and to leave them out until they were collected, which might be one or two days later. Councillors commented that some of the blue bins presented for collection in the village had blown open and scattered rubbish across the village. Councillor Stott had produced drawings of the current and proposed pond tree layout for the planning application required to progress with the pond project.

Resolved – i) Councillor Gibbs would prepare a short flyer to the affected residents advising them of the bin collection arrangements during the road works and ii) a future newsletter should ask residents not to present blue bins on the evening prior to collection if windy weather was forecast and iii) the pond task group should review the drawings and arrange for the planning application to be submitted.

58/20 CORRESPONDENCE – Resolved – i) that the following correspondence should be received by the Council:

ii) that the Clerk would query the number of lights included in the street lighting service level agreement, and whether more energy efficient lighting could be used.

59/20 STREET NAME BANK – Further to minute 44/20, the Parish Council discussed a number of suggested names for the village street name bank.

Resolved – i) that the names Harthill, Knights, Lowthropp, Carling, Hudson, Etton Pasture, William Andleby, Ousteby and Owstaby would be submitted to ERYC to replace those currently in the name bank and ii) the Parish Council would write to any developer that submitted an application for more than 1 new property in the village to request consultation on any street naming.

60/20 TO CONSIDER THE REQUEST TO ADD ADDITIONAL NAMES TO THE WAR MEMORIAL - The Parish Council had been requested by a resident to install a plaque on the war memorial to commemorate parishioners who had served during the Second World War. Councillor Armstrong had sourced a list of names from the East Yorkshire Family History Society. Guidance issued by the War Memorial Trust stated that a memorial belonged to the community, and that any additions should therefore be a community decision. The guidance also said that a memorial might commemorate those who had served or those who had fallen in a war. The cost was likely to be approximately £500. The Parish Council agreed that this was very sensitive request, which presented challenges in the definition of the term “active service” and created a risk of upsetting parishioners who had contributed to the war effort at home but were not recognised in the records. It raised a question as to whether other conflicts should also be remembered and also to what extent accuracy of names could be guaranteed after 75 years. Councillors also recognised the importance of World War 2, remembering those who served and maintaining historical records.

Resolved – i) That the Parish Council would consult the community on the proposed addition ii) that the Parish Council would arrange for a plaque to be installed on the memorial, unless there were objections arising from the consultation and iii) the consultation wording of the plaque should read “To Commemorate those who Served in the Second World War 1939-1945”.

61/20 KIPLINGCOTES DEFIBRILLATOR – Each year the Hull Corn and Feed Trade Association donate a defibrillator to a small community in East Yorkshire, and this year had chosen Kiplingcotes. The Parish Council would be responsible for the ongoing maintenance costs and training. Kiplingcotes Furniture had agreed to have the defibrillator fitted to their building, and to monitor the unit.

Resolved – That the Parish Council would gratefully accept the offer from HCFTA for a defibrillator for the hamlet of Kiplingcotes.

62/20 – PARISH CHRISTMAS TREE – Resolved – That Councillor Holmes would purchase the Christmas tree and install with the support of Councillors Sleight and Widd.

63/20 TO AGREE ACCOUNTS FOR PAYMENT – Resolved – That the following accounts would be approved for payment:

66/20 ETTON WAR MEMORIAL – The Parish Council reviewed the resolution to Minute 60/20. Councillor Holmes provided an update on the written and verbal comments provided by Councillors Bell and Gibbs. The Parish Council agreed that too long a period of time had passed to have confidence that any names identified in historical records accurately reflected those who served during the Second World War.


Resolved – i) that parishioners would be consulted on whether a plaque reading “To commemorate all of this Parish who have served during conflicts and wars” should be added to the War Memorial ii) that the Clerk would ask the Village Hall Committee whether a framed Roll of Honour, based on the identified historical records, could be displayed in the Village Hall.

67/20 PARISH COUNCILLOR UPDATE – It was noted that Councillor Holmes had written to Mrs Armstrong to express regret at her decision to resign as Parish Councillor, and to thank her for her years of service to the Parish. Councillors Holmes, Sleight and Widd were thanked for buying and installing the Village Christmas Tree. It was also agreed that i) the Clerk would report again the missing Give Way sign at the Dalton Hill / Warter Road Crossing and ii) Councillor Stott would consult the properties at the back of Etton Mere on the proposed planning application before submitting to East Riding of Yorkshire Council and iii) that the scheme submitted should be for the removal of the Willows and the poor quality / self-seeded trees.

Do not keep large amounts of money in your home.

Never leave your car unlocked.

Always remove anything that can be stolen from view in your car. The cost of the item may be low but the damage to your car will be costly.

Keep cycles safe

- use a cycle lock,
- get your cycle coded, speak to your local police

If someone visits your home always ask for identification.

Never leave anything in your garden that can be used to break into your property. If you have ladders keep them secure.

Do not keep valuable items in insecure outbuildings.

Report broken street lights to (01482) 393939 with the necessary street light number which can be found on the lamp post.

Tell your landlord if you are leaving your home empty for a period of time.

YOUR Community YOUR Responsibilities

Being a Good Neighbour

Children love to play, but sometimes we need to remind them to be considerate to others.

- Ask permission to retrieve balls from others properties
- Don't allow your children to be a nuisance to other residents, this includes kicking footballs at fences or garages

Keep your garden / yard tidy and litter free. This prevents pests and makes the area in which you live a pleasant place.

If you are going to have a party or doing any repairs to your property, tell your neighbour and make sure the noise begins and ends at reasonable times.

If you have a dog, make sure you clean up after them - dog fouling can result in a minimum of £75 fine. Also, ensure that you keep your dog on a lead in public places and under control.

If you have a vehicle, do not block others driveways.

After your dustbin has been emptied, take it back into your garden / yard. Do not leave dustbins in alleyways as this causes an obstruction to emergency vehicles.

If you have bulky items e.g. furniture there are many ways to dispose of it:

- Take it to the tip
- Contact a charity that is able to recycle/reuse your items
- Contact East Riding of Yorkshire Council on (01482) 393939 to arrange for the items to be collected

YOU are responsible for all children, pets and visitors in your property.

What is Anti Social Behaviour?

Anti - social behaviour may include things such as:

- Rowdy, noisy behaviour
- Night time noise from houses or gardens
- Abusive, intimidating language
- Spitting in a public place
- Threatening drunken behaviour
- Vandalism, graffiti and fly-posting
- Dealing or buying drugs on the street
- Litter and fly-tipping rubbish
- Aggressive begging
- Drinking alcohol in the street
- Setting off fireworks late at night
- Underage drinking of alcohol

Anti-social behaviour doesn't just make life unpleasant, it can ruin lives and make the area feel unsafe.

If you encounter anti social behaviour, visit the East Riding of Yorkshire Council's website as this contains useful information and will help you report it to the correct service.

East Riding of Yorkshire Council and Humberside Police work together with other services to stop anti-social behaviour.

What is a Crime?

A crime is an act of breaking the law. Committing a crime can lead to prosecution and imprisonment.

Here are some crimes that can lead to arrest by the Police and prosecution in the criminal courts:

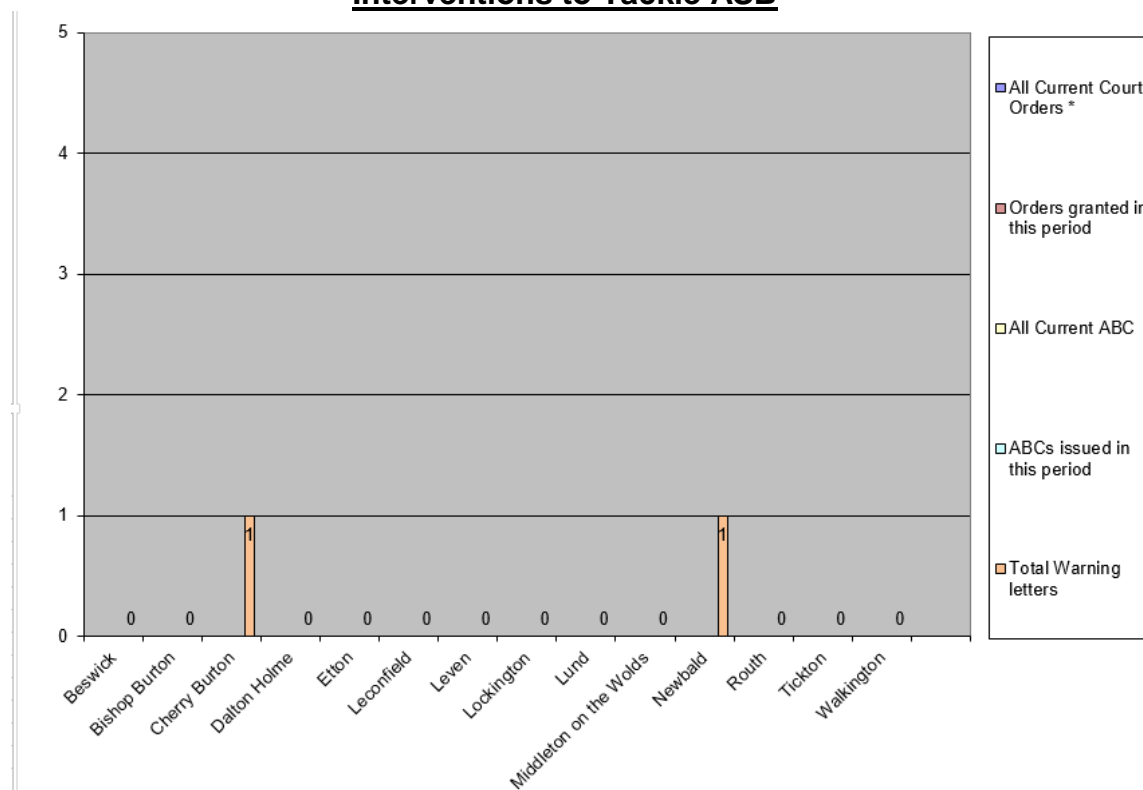
- **Assault**; causing physical harm to another person.
- **Theft**; taking items that do not belong to you or you have not paid for e.g. shoplifting.
- **Criminal Damage**; causing damage to property or vehicles which do not belong to you.
- **Burglary**; e.g. breaking into or sneaking into peoples' houses and stealing their property.
- **Rape**; e. g. having sex with someone when they don't give consent, (even your wife). It is also considered as rape if you have sex with a girl under 16 even if they give consent.
- **Drunk and Disorderly**; e.g. shouting and swearing in the street whilst drunk, or urinating in public view whilst drunk.
- **Drink Driving**; driving a car after drinking alcohol can lead to arrest and prosecution, and being banned from driving.
- **No Insurance**; to drive a car on the road in the UK the vehicle needs to be insured.
- **Possession of Controlled Drugs**; for example, being found with cannabis can lead to prosecution.
- **Public Order Offences**; includes swearing and shouting, threatening behaviour, fighting, and violence in general. If these offences are racially aggravated, you can expect a stiffer court sentence.
- **Domestic Violence**; (including rape and assault), threatening behaviour, violence or abuse between adults who are or have been intimate partners or family members.

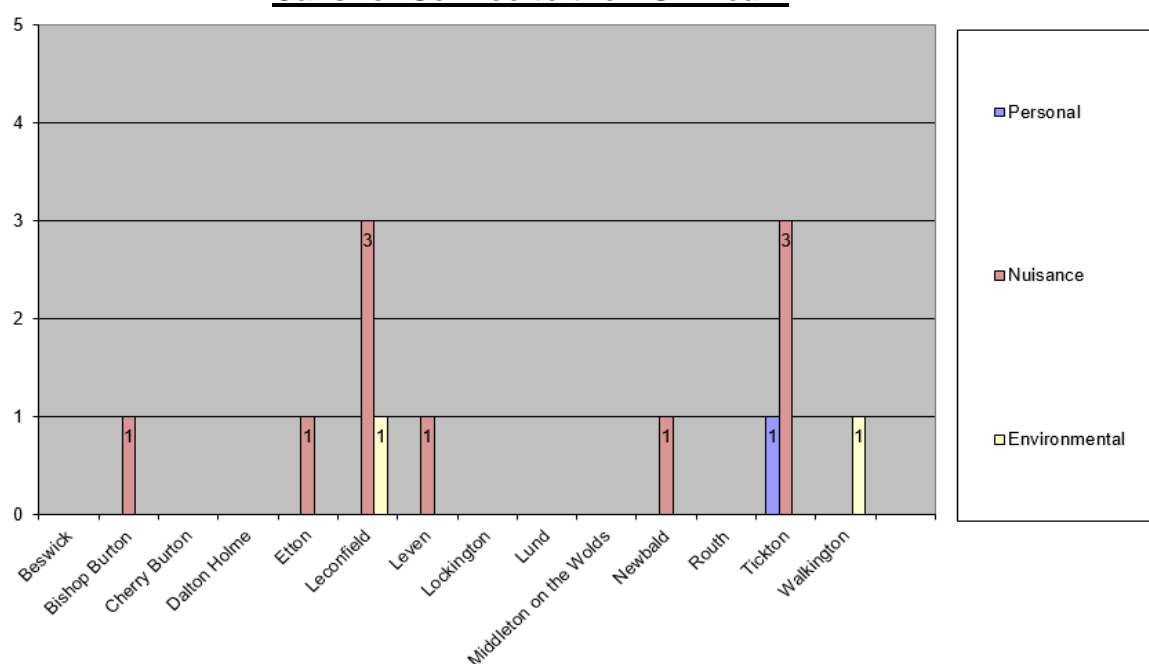
Breakdown by Parish and Town Council area

Calls for Service to the ASB Team

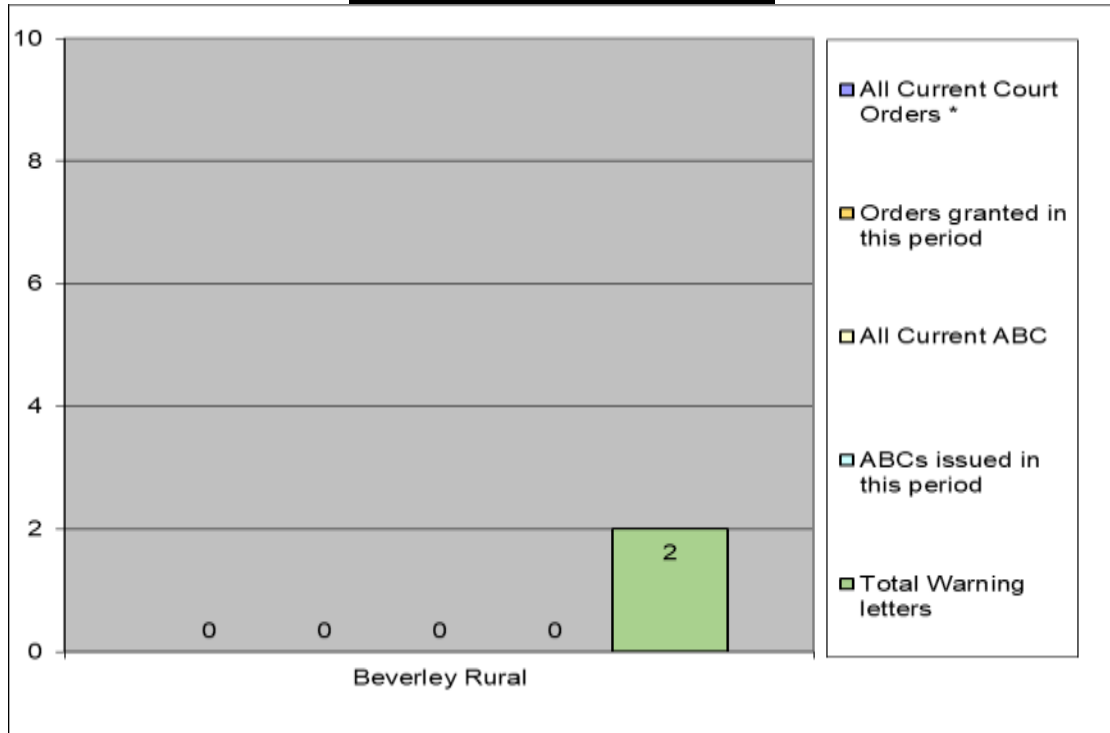

Six month data represents 1 April 2020 to 30 September 2020

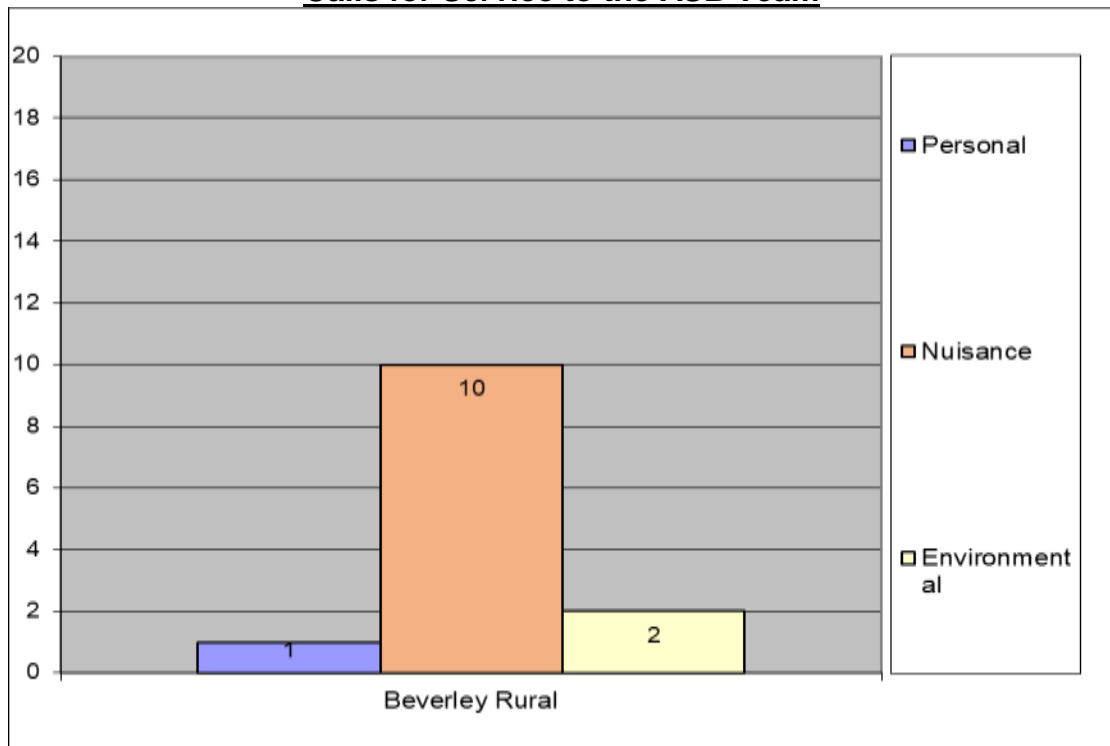
Breakdown by Ward

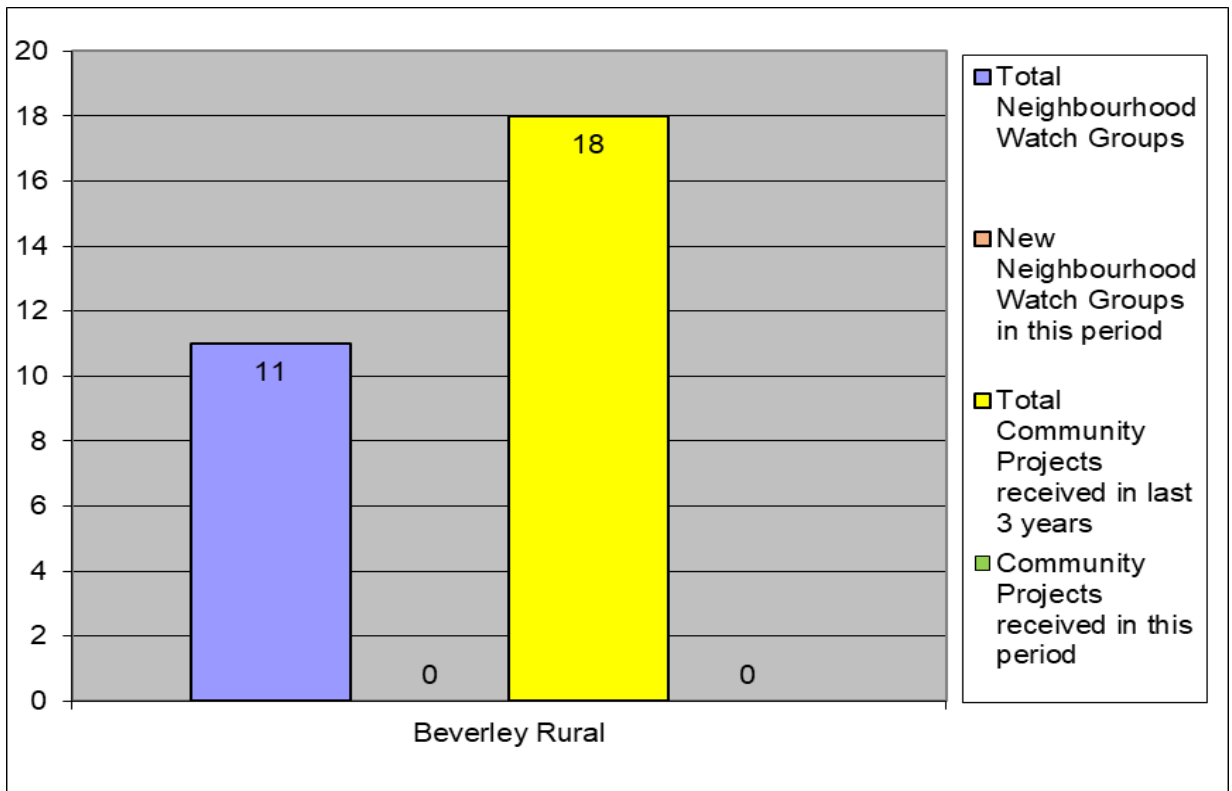
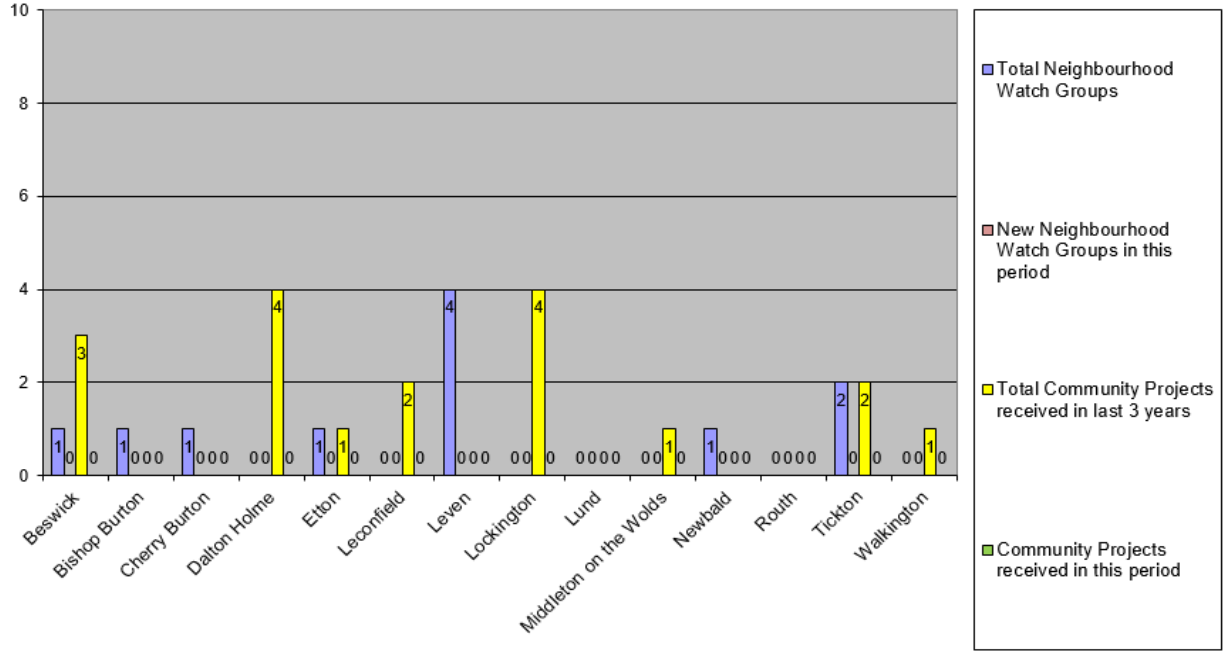

Hello,

I know it has been a while since I sent you a Bulletin but the world had been a strange place and the pandemic has really altered the way we all work with change happening sometimes very often.

**First, a message from the Police & Crime
Commissioner for Humberside, Keith Hunter,**



We approach Christmas and the traditional festive season this year with the whole world having been significantly shaken during the past 10 months or so. Things we took for granted as being basic freedoms or had come to think of as almost entitlements, have been taken from us as we have all worked to contain the worst excesses of covid 19. Many loved ones are no longer with us and innumerable others have lost jobs or are worried they may do so as the effects of the damage to the economy continue to cause problems into the future. We should all give some time to reflect on the lives disrupted and the loss felt by so many across the country and, indeed, the world.

The news of vaccines beginning to be distributed should give us all hope that our health, at least, may be at less immediate risk in the near future. There is currently, however, still a significant risk to health and to the ability of our health services to care for the ill if we do not take seriously the continuing threat covid presents. For that reason I hope you will consider carefully how you celebrate Christmas and enjoy the festivities this year.

The officers, staff and volunteers of Humberside Police have worked hard throughout this year attempting to engage with communities and work with them to keep us all safe. Dealing with criminality, anti-social behaviour and the impact of covid on every aspect of police activity has been a major challenge but, in addition, so much of what the force does, largely unseen, in protecting vulnerable people from those who prey on them has been massively impacted by lockdown and restrictions. My office, the OPCC, has also continued working, ensuring the Force are in tune with their communities and that services for victims are capable of providing essential support during these changed and challenging times.

It has been a tough year but one that has seen your local police service illustrate the great strides forward it has made in recent years. When you are celebrating during this brief period of respite over Christmas, your police service will still be out there working to keep you safe. It's what they do, often with little thanks or recognition.

I hope people will be a bit more reflective this year in recognition of the unprecedented period we are living through. So, perhaps you can all give some thought to our police officers, staff and volunteers, but also our health-care workers and all the others in the public, private and voluntary sector who ensure we are kept safe, healthy, provided with access to food and fuel and who provide all the real essentials that we perhaps may have taken for granted, before covid opened our eyes to the fragility of day-to-day life as we know it.

I wish you all a peaceful and happy Christmas and festive period.

Meet the Commissioner

Over recent years, many of you have taken the opportunity to attend one of the many Meet the Commissioner events we have hosted across the East Riding. Regrettably, we have been unable to run these events this year so we have moved them online using Zoom. It's quite different doing it this way because we don't have to worry about you all driving at night and in bad weather. You can hear about his work, ask questions and talk to the PCC from the comfort of your own home. The dates are:

Increasing Policing Numbers in the East Riding (Chief Superintendent Darren Downs, North Bank Commander, Humberside Police)

In 2014, Humberside Police had 1420 Officers and, as of November 2020, numbers have risen to 2036 police officers, an increase of 616 across the Force. The rise has enabled the re-introduction of 12 response Officers into Pocklington with a further 4 soon to arrive. These are officers who work 24 hours a day responding to emergency and urgent calls for service.

Neighbourhood Policing is also growing in the East Riding with the introduction of new Community Beat Managers (PCs) in Market Weighton, Cottingham and Hessle.

Humberside Police are introducing a new Rural Task Force of a Sergeant and four PCs who will be based at Driffild Police Station and will concentrate on crime in rural areas such as theft of plant and travelling criminals across the East Riding. This is in addition to the specialist Wildlife, Rural and Heritage Crime Officer PC Rich Fussey, now dedicated to the north bank being Hull and East Riding rather than the whole force area. They also wanted to strengthen their response to rural and organised and have increased capacity in technology for operational officers.

They have recently introduced a Roads Crime Team, specialist traffic Officers who focus on those using our road network in the commission of crime. Humberside Police used the opportunity in the first lockdown to form Operation Galaxy which concentrates on developing intelligence, executing warrants and making arrests of organised crime groups operating across all four of the local authority areas in Humberside. They have had remarkable success in the East Riding with multiple seizures of drugs, money, counterfeit goods, arrests and property closures, the most recent being the discovery of a cannabis farm in house in Beverley.


CID Officers have been reinstated in Goole and Beverley and a dedicated Domestic Abuse Team is also being introduced in early 2021.

Officers have continued with their force wide community engagement programme Humber Talking and have knocked on 27,150 doors across Humberside with many in the East Riding asking residents what their community concerns are and feeding them into the setting of policing priorities for their area.

Chief Officers are active Members of the Local Resilience Forum which brings agencies together in response to Covid. Humberside Police have remained visible and this is with particular thanks to the Special Constabulary in East Riding who's level of commitment and hours of volunteering have been remarkable.

There has been recent agreement for Humberside Police to be a key partner in multi agency projects in areas of Bridlington and Beverley improving neighbourhoods and making places safer.

Other good news is that crime rates in Humberside are down having started to reduce before Covid. Calls and contact levels about Humberside crime and criminals to Crimestoppers have increased. One important message is that it is people who stop crime.



RURAL POLICING PRIORITIES

Both the PCC and the Chief Constable are keen for the views of communities to influence local policing priorities. With the growth of policing and the introduction of the new Rural Crime Task Force to the East Riding there is no better time to seek those views. 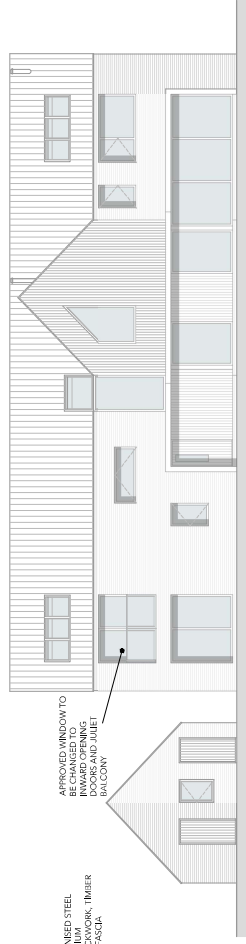

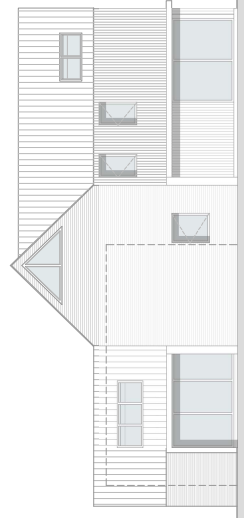

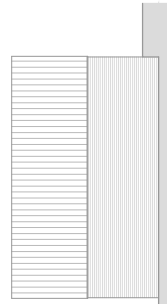

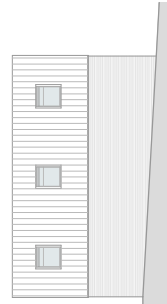

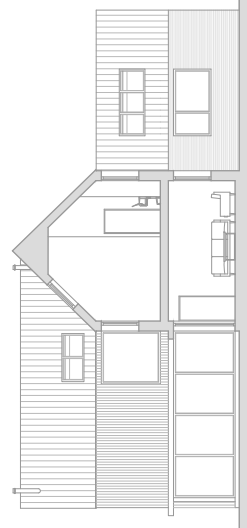
