## ETTON PARISH COUNCIL MEETING

11 March 2024

**PRESENT:** Councillor Holmes (Chairman), Bell, Heuck (from agenda item 19) Sleight, Stott and Yeo.

Ward Councillor Wilcock was also in attendance.

5 members of the public were also present.

**Public Forum** – A question was asked about the arrangements for the Fish and Chip van for the D-Day Commemorations. It was noted that payment would be taken on the evening rather than in advance.

**17/24 DECLARATIONS OF INTEREST** – There were no declarations of interest.

**18/24 MINUTES OF PREVIOUS MEETING – Resolved** – that the minutes of the Parish Council meeting held on the 8 January 2024 should be approved as a correct record and signed by the Chairman.

**19/24 CO-OPTION OF NEW COUNCILLORS – Resolved** – that Mr Heuck and Mr Williams should be co-opted to the parish council.

**20/24 WARD COUNCILLOR UPDATE** – Councillor Wilcock noted that the planning application for the houses at land to the rear of 97 Main Street had been refused. The Parish Council thanked Councillor Wilcock for representing the views of the Parish at the committee. The devolution consultation had closed, but the outcome and next steps had not yet been announced. There had been changes to the political make up of East Riding of Yorkshire Council following by-elections, but no change in the overall control, or to the principal of joint working between all parties. Council tax would increase by the maximum 4.99% in 2024/25 because of the challenging financial position faced by all local authorities.

**21/24 ACTION LOG UPDATE** – ERYC had made contact asking to inspect one of the lamp posts prior to installation next to the Village Hall. Councillor Yeo agreed to make enquiries about a location for a street lamp at the west of the village. It was agreed that the Clerk would ask the enforcement officer for an update on two outstanding planning queries raised. Councillor Stott intended to ask for more volunteer time at the pond for a further tidy up, and perhaps some additional hedge planting. Councillor Stott was also going to ask for a quote to tidy the laurel. It was noted that the bird box scheme was ongoing, but it would be too late to install any for nesting this year. East Riding of Yorkshire Council had advised that it would be unlikely that the Section 19 report into the winter flooding would answer the questions posed by the Parish in its return to the investigation. A detailed hydraulic report would be required to determine some of the answers, and these were expensive and not in scope of the report. A resident at the meeting said there had been more than 20 occasions during the winter where water had run off the fields through gardens, and down drives, eroding the pavement, silting up Yorkshire Water inspection chambers and causing flood risk to properties. The resident said was unfair that a small number of properties should bear the brunt of the risk. The Parish Council sympathised with the situation but it was not clear what else could be done. It was agreed that the Parish Council would accept ERYC's offer for a meeting and walkabout to discuss flood risk. Councillor Wilcock agreed to speak to ERYC about the outcome of the S19 report and with Dalton Estate about the potential for planting trees and considering other flood mitigation measures.

**22/24 PARISH COUNCILLOR UPDATE** – There were no updates not already on the agenda.

**24/24 PLANNING APPLICATIONS - Resolved** – that the Parish Council had no comments to make on planning application 23/03518/PLF4, Templar View, for the installation of soakaway attenuation crates following removal of 100mm diameter soakaway pipework.

**25/24 RECENT FLOODING – Resolved** – that the Parish Council should formally record its thanks to the local business owner who helped clear Etton's Gullies during recent flooding events.

**26/24 D-DAY COMMEMORATIONS 2024** – Councillor Holmes had booked the mobile fish and chip van for the 6<sup>th</sup> June 2024. There had been a number of offers of support for the event, including lighting the beacon. The meeting discussed arranging fireworks, but felt that it would be too disruptive to horses in the area and not in keeping with a commemorative event.

**Resolved** – i) that the Parish Council would offer some light refreshments at the beacon lighting ii) that the Clerk would formally ask the landowner's permission to light the beacon and iii) that the arrangements would be promoted in the next newsletter.

Yorkshire Wolds Cycle Challenge	Once again I'm emailing to advise you that the 13 <sup>th</sup> running of our fundraising event is due to take place again over the weekend of Saturday 29th & Sunday 30th June and we are due to pass through your parish on the Saturday between 11.30am and 1.30am. The event has become a hugely important part of our fundraising activity, raising in excess of £30,000 last year and a total in the region of £250,000 over the years. *At this time of year when spring arrives and the clocks go forward, Burglaries of sheds and garages usually start growing! The police together with Neighbourhood Watch Groups are asking for your help. The value of property in sheds and garages is more than people think. Thieves are targeting them for power tools, cycles, and sports equipment. Hand tools are stolen and used to break into homes.*

### **Action**

*During this month members of all three Policing Teams will continue be out and about providing residents with advice on home security.*



*Let's weed out these thieves by getting some sheducation!  
Secure the access to your shed or garage by locking gates and using thorny bushes.*

*Have you visibly marked the contents of your shed? Note of serial numbers, take photos.*

*External security lights which are activated by movement are a useful deterrent.*

*Doors of sheds require attention. Use strong hasp/staples and close shackled padlocks.*

*Use coach bolts or non-return screws to secure door hinges.*

*Chain cycles, mowers, ladders, and tools to a strong anchorage point.*

*Alarms for sheds and garages are available for under £20 at most DIY stores.*

*Together we'll crack crime. Join a home watch scheme.*

*Exactly what insurance cover do you have? Check that your household policy covers you for theft from your garden and outbuildings.*

## **Action**

*During this month members of the Beverley Rural Policing Team will continue to be out and about patrolling the community to deter anti-social behaviour along with reassuring the public.*

## **2. Preventing Anti-Social Behaviour**

*Antisocial behaviour (ASB) is any conduct that has caused or is likely to cause harassment, alarm, or distress to any person. It comes in many forms of behaviour that provoke a range of responses, from mild annoyance to overwhelming fear and insecurity. Incidents may be isolated or within a pattern of behaviour, and ASB can have a devastating effect on the lives of people and their communities.*

*Depending on the nature of the behaviour, it can be dealt with by the police or the antisocial behaviour team at your local council.*

## **No Bad Treatment campaign launch**

We are inviting anybody in the area who works in the health and beauty industry to an online event which will launch a new campaign: No Bad Treatment.

The campaign aims to raise awareness of domestic abuse, offer brief training on how to spot the signs, and provide information support services to those working in the health and beauty industry so they can discreetly signpost clients, colleagues, family, or friends.

The [online launch event](#) takes place on Tuesday, 16 April, from 7pm-8pm.

The campaign offers free training for hairdressers, aestheticians, beauty therapists and students.

The session will provide the tools and resources to support a client who is experiencing domestic abuse.

Councillor Leo Hammond, our cabinet member for planning, communities and public protection, said: "Domestic abuse is a huge issue in our society, affecting one in four women and one in six men over their lifetime. On average, a victim will experience abuse 50 times before seeking help, and sadly may go to as many as five different agencies before finding the appropriate help, advice and support.

"We are aiming to educate people who may be in a position to spot the signs and signpost correctly, and so we hope to dramatically reduce this number."

## **Funeral director visits completed in Hull and East Riding**

Visits made to all funeral directors in Hull and the East Riding have now been completed, as a consequence of the on-going Humberside Police investigation into Legacy Independent Funeral Directors Ltd.

Public protection teams from Hull City Council and East Riding of Yorkshire Council have spent the past three weeks speaking to funeral directors and carrying out visits to their premises.

Officers from both authorities made a total of 50 visits to review compliance with health and safety regulations, operational procedures and care of the deceased, and to offer support and advice to businesses.

## Bowel Cancer Awareness Month

Throughout April we are supporting the work of the Humber and North Yorkshire Cancer Alliance to raise awareness of bowel cancer and encouraging **people aged between 56 and 74** to complete a home testing kit that can detect signs of bowel cancer, as part of its **#flushawaybowelcancer** campaign.

If you are aged 56 to 74, you should receive your bowel cancer screening kit through the post. The NHS automatically sends a kit every two years to people in that age group but data shows that one third of people sent a test in 2023 did not go on to complete it.

## COVID-19 'Spring Booster' booking opens from Monday

The NHS national booking system will open again for spring COVID-19 vaccination bookings on Monday, 15 April, with those eligible able to book appointments from the following week.

People at increased risk from severe illness can get the vaccine, including those aged 75 or over (on 30 June 2024), people with a weakened immune system or those who live in an older adult care home.

Spring vaccinations will be available until Sunday, 30 June 2024.

Anyone eligible can book a vaccine appointment via the [NHS.UK website](https://www.nhs.uk) or by calling NHS 119 for free, with parents or carers able to book a COVID-19 vaccination for children under 16 on their behalf. Eligible residents aged 16 and over can also use the NHS App to book an appointment.

Please note, although the NHS is sending texts, emails, NHS App messages or letters to those who are eligible, residents do not have to wait for an invite to book if they are eligible. Visits to older adult care homes and eligible household patients will also begin from Monday across England.

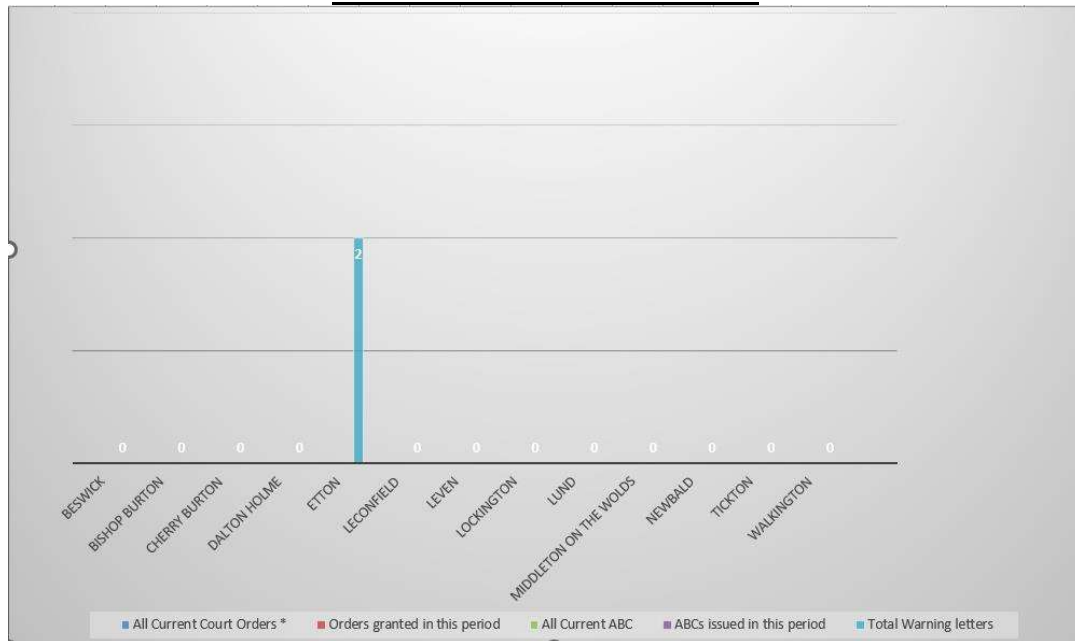

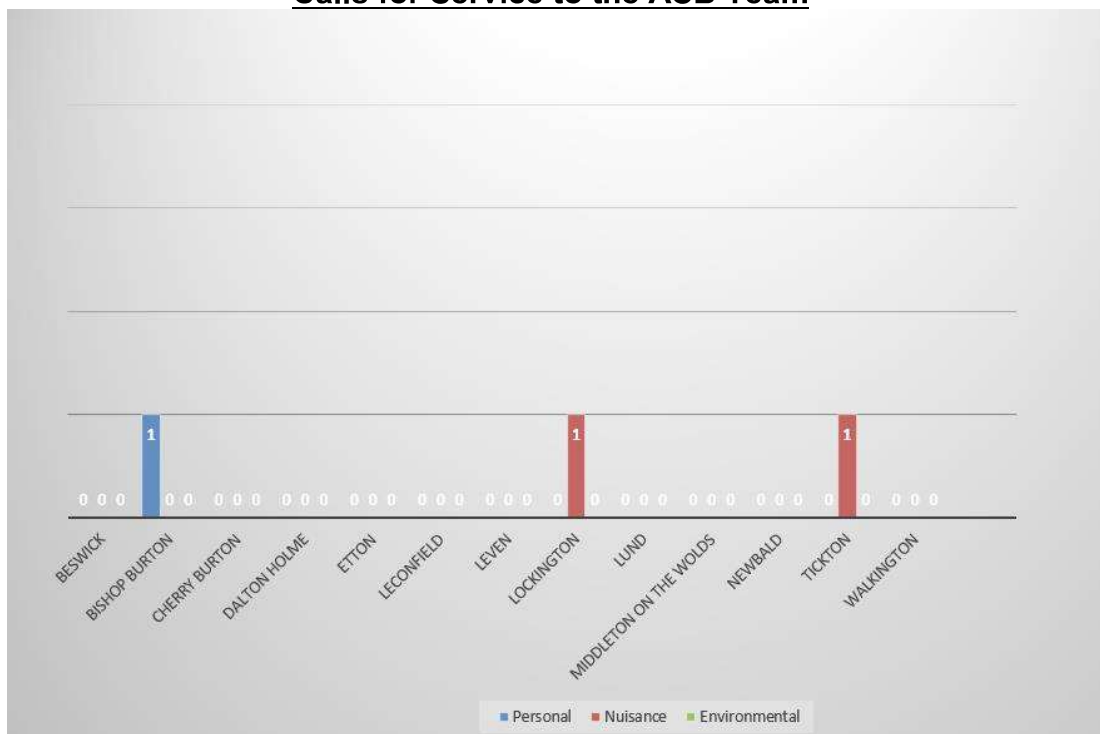
### Breakdown by Parish and Town Council area

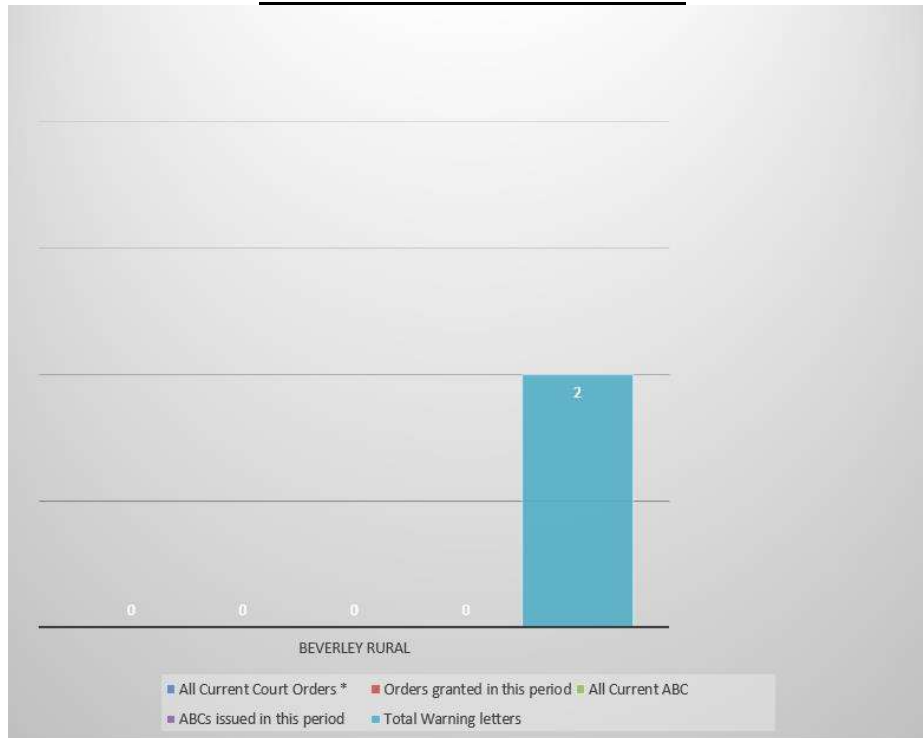

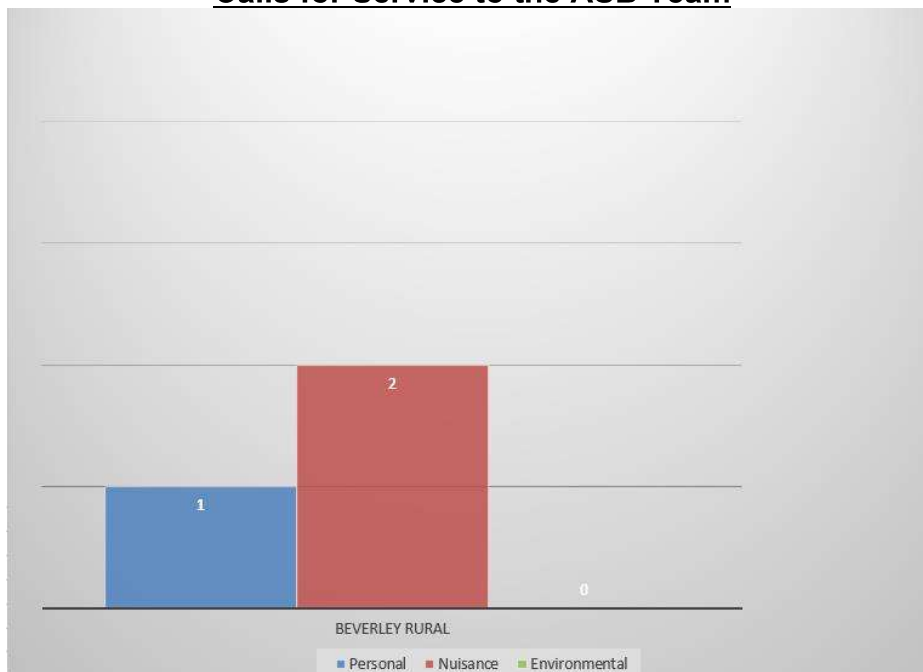
### Breakdown by Ward

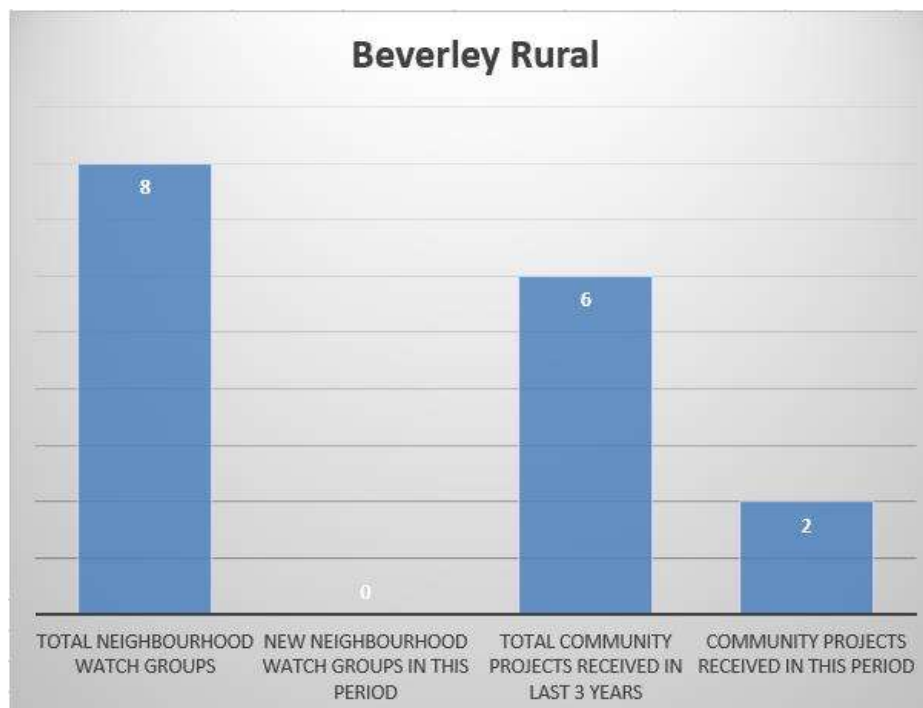
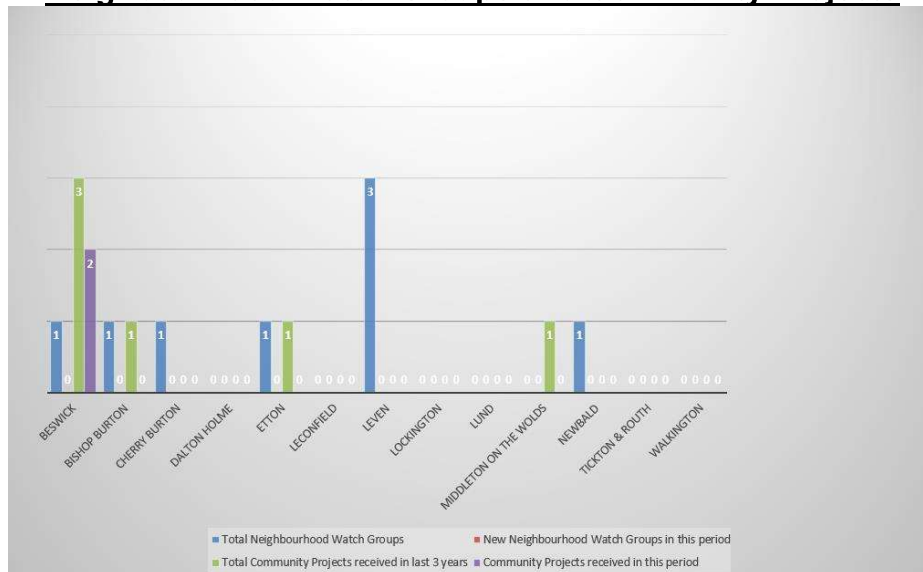

**Reply from ERYC Principal Engineer – Flood and Coastal Risk to points raised by the Parish Council, following a letter from Councillor Wilcock**

- Suggest different land management practices and whether measures such as tree planning, buffer and filter strips and other good soil management practises could be used effectively to reduce flood risk (recognising that this would be down to the land owner to introduce). There may be benefits to tree planting but it would be difficult to quantify, although in my opinion flood risk benefits would be limited. In order to assess changes to surface water flows with any physical measures we would need to employ a specialist consultant to undertake hydraulic modelling. Although physical interventions may reduce flood risk to some areas or properties, they must not increase flood risk else where, which is why it would need modelling. The PC are correct, the modelling and any physical works would not be funded by the Council.
- Make assessments on the value of Property Level Flood Protection from individual properties. We always recommend that residents should consider investing in Property Level Flood Protection measures if they feel that their property is at risk of flooding. Every property, however, is different, and we cannot resource or fund individual property surveys in order to make recommendations, again the number of properties in question throughout the East Riding is significant.
- Make recommendations on whether raised curbs may be enough to deflect some water away from the older properties on Main Street that have next to no threshold in to houses. This would be more of a question for colleagues in Highways. They would, however, need more details in terms of proposed locations. It isn't always as easy as just raising kerbs because it could result in the footways having to be lifted creating a backfall. Again, where the funding comes from would need to be considered.
- Provide advice on whether there would be any value in reinstating historic ponds in the village. More details would be required, but again, I suspect that an element of hydraulic modelling would be required in order to assess the pro's and con's. The Council could not justify funding the modelling or any resulting physical works.
- Provide more details about the ownership / value / of the drainage chamber to the West of the Village. More details required, I do not know which chamber the PC are referring to.
- Advise whether individual landowners raising land (bunds) at the rear/ sides of their gardens and deflecting flows is a feasible option, or asking landowners to dig ditches to divert flow. This would need hydraulic modelling in order to assess the benefits, and to ensure flood risk will not increase else where.
- Provide a survey to help with some of these assessments, so that the Parish Council and residents could work with landowners to explore potential options. Any survey works would need resourcing and funding.
- Make recommendations on whether Etton gullies could be marked for annual jetting after harvest. This would be a question for colleagues in Highways,

although I suspect that they have received similar requests and considered this option for many rural areas.

- Make recommendations on whether low lying points of the drainage system could be inspected for silt. In order to assess the level of silt build up within the culverted watercourse, a specialist Contractor would need to be appointed to jet and CCTV survey the system. We have a term service contract with a specialist contractor, and we have discussed the possibility of checking the culverted watercourse which runs along Main Street. This is a riparian owned system and not the Councils responsibility to maintain, although if funding becomes available we can add the site to our programme of works.
